Anfield, Liverpool FC

Planning for Anfield's expansion

Plans to increase the overall capacity of Anfield Stadium from about 45,000 people to 61,000 following the phased redevelopment of the Main Stand and the Anfield Road Stands. We co-ordinated the planning applications and production of technical reports and led negotiations with the Local Planning Authority and statutory consultees. We also led the subsequent planning application for a new free standing club store adjacent to the stadium. The scheme is an integral part of the Liverpool City Council's vision for the wider Anfield area to which significant public sector investment has been committed. Throughout our work with LFC, we played a pivotal role in devising the planning strategy for the club's proposals, working in close collaboration with the council, key stakeholders and the local community. Moreover, we also established strong working relationships with all interested parties, including community groups, meaning the once controversial proposals have attracted significant community support.

Liverpool FC Training Complex

Development of a new world-class training ground for Liverpool Football Club

Since 1998, Liverpool Football Club Academy has operated at its current site, with the First Team training at Melwood, Liverpool. To consolidate operations and maintain elite status, the club aimed to merge the two locations into a comprehensive 'Training Ground.' Negotiations with Knowsley Council involved enhancing community playing fields while intensifying their use by local sports clubs. We provided Planning services for permissions and advised on a Road Closure Order for site assembly. Collaborating with the club's PR team, our Strategic Communications team managed community engagement.

Ongoing tasks include discharging conditions and managing adjustments to the facility plans. Co-operation with the Football Club, local authorities and Sport England facilitated planning permission for the training ground and community sports facilities. Construction was completed, with community pitches operational and the training ground launched for the 2020/2021 football season. Additionally, we secured consent to redevelop the existing Melwood training centre into family housing.

Bath Stadium / Farleigh House

Transformational development at Bath Rugby Club's Recreation Ground

Providing planning advice to Bath Rugby Club regarding various proposals both at its training ground and headquarter facilities at Farleigh House (located within the Green Belt), and with respect to its proposals to deliver a new stadium for Bath at the Recreation Ground.

As the stadium is located within the World Heritage City of Bath and conservation area, it is a very constrained site, but we have facilitated the planning policy framework to support a new purpose-built facility. An allocation for a new stadium at the Recreation Ground, Bath was secured in the council's Core Strategy (2014) and subsequent Placemaking Plan (2017).

We prepared a Development Brief for the site and provided Planning, EIA, and prepared an Economic and Social Value Assessment to support the planning permission. We also submitted a detailed planning application in September 2023.

Emerge Surf

Providing advice for one of the largest wave parks in the UK

Our expert Planning advice to Emerge Surf supported their detailed planning application for a £50 million wave park within the Green Belt.

The proposals, centered around a 5.4-acre WaveGarden Cove surfing lagoon, will create a major visitor attraction that will deliver an annual economic boost of between £18 million - £21 million to the region. Visitors will have access to a surf academy, equipment rental and surf store, restaurant areas with co-working spaces and additional recreational activities including hot tubs, a playground and pump track.

Planning permission was granted in 2020 and the scheme is currently under construction following the acquisition of the site by Stoneweg InfraSport in early 2024.

Sandwell Aquatics Centre

Delivering the only brand-new venue for the 2022 Commonwealth Games

We provided planning consultancy on the delivery of Sandwell Aquatics Centre, a new purpose-built facility to host the aquatics events for the Birmingham 2022 Commonwealth Games. A full planning application was submitted and subsequently approved within a 13-week determination period, representing the achievement of a significantly reduced timescale whilst maintaining the highest quality, reducing risk of post-submission delays and ensuring readiness for the Commonwealth Games. Following the Games, the building was retrofitted with sports halls, fitness suites, studios, gym, outdoor football pitches, play spaces and landscaping, in accompaniment to the pools and 1,000 retained spectator seats. The development has delivered a lasting legacy for Smethwick, addressing an under provision of sporting facilities in the area.

Compton Park, Wolverhampton

£50 million investment in education and sport

Wolves' previous training ground at Compton Park was the Premier League's smallest. The £6 million investment aimed to revamp the facility, including a new indoor pitch (100m x 60m), upgraded outdoor pitches and additional sports amenities, aligning with the FA Premier League's academy football standards. Despite its Green Belt designation, we presented a compelling 'very special circumstances' case for development. Our Design team devised a site-wide masterplan, crucial for consultation events. The project gained approval for a redesigned school, a consolidated football academy and executive housing. Completion resulted in high-quality sports and educational facilities, along with local housing in a sustainable location.

National Sports Centre, Crystal Palace

Upgrading sport and leisure facilities within the setting of a Registered Park and Garden

Our Planning and Heritage & Townscape teams collaborated with Hawkins Brown Architects as part of a multi-disciplinary team advising the Greater London Authority (GLA) on the future of the Crystal Palace National Sports Centre (NSC). The NSC, a grade II* listed building within a grade II* Registered Park and Garden, sits amidst various heritage assets and Metropolitan Open Land. The GLA seeks to refurbish the NSC, enhance its energy efficiency, and explore future sports and leisure possibilities. Formal pre-application discussions were held with the London Borough of Bromley and Historic England, alongside engagement with stakeholders and the community. Proposed options include removing redundant structures and introducing new purpose-built facilities to accommodate diverse sports and leisure activities for the modern era.

Edgbaston Stadium

A county ground with an international reputation and vision for growth

We have provided long-term advisory services for the redevelopment of Edgbaston Stadium and the Edgbaston Foundation Sports Ground in Smethwick. Our role includes strategic planning, communications advice and engagement with planning policy. We continue to work on the “Stadium and Community” Masterplan, aiming to transform the stadium into a mixed-use destination with elite cricket and community facilities. Collaboration with Birmingham City Council and other local entities is key to realising this vision. The masterplan encompasses community facilities, a Learning & Development Centre, new seating and a hotel. Our partnership with Birmingham City Council led to securing planning permission for stadium improvements and a framework for various developments, including residential, hotel, office and leisure spaces. We also facilitated permission for the adjacent Corkfield residential scheme, enhancing the visitor experience and public space in Birmingham. In February 2025, an application for the new hotel and stand to replace the Priors & Raglan Stands received resolution to grant at Planning Committee.

Leicester Tigers RUFC

Enabling phased redevelopment of the ground

Leicester Tigers is one of the most successful RUFC clubs in the country, playing in front of maximum capacity grounds. Working closely with the club and the local planning authority, we devised a planning strategy that would enable a phased redevelopment of the ground, ensuring that the club continued to play at the ground and spread the cost of the works over a period of years. The first phase comprised the single-tier north stand with a capacity of 17,000.

We successfully negotiated with the LPA to screen out the need for an Environmental Statement and then co-ordinated the preparation of all of the relevant technical reports.

The LPA has an adopted policy requiring the provision of 11% renewable energy on site, increasing by 1%pa to 15%. Full planning permission was granted within 13 weeks.

Edge Hill University Campus (including Sports Centre)

Strategic advice to support the university's investment in its campus

We have provided ongoing strategic advice to Edge Hill University since 2004 and have secured planning permission for a number of projects. This includes their £30m sports centre, with an eight-court sports hall and viewing gallery, a 25-metre swimming pool, an 80-station fitness suite, aerobics studio, health suite with sauna and steam rooms, plus a café and lounge area. Its international competition standard outdoor facilities include one of the largest running tracks in Europe, plus rugby, hockey and football pitches, an athletics field, netball and tennis courts.

The facility is open for use both by students and the wider community.

We have also supported the university to scope out an approach to measuring and evidencing its economic and social value, highlighting the multiplicity of ways in which the university enriches the social, sporting and cultural life of West Lancashire.

Providing valuable leisure and fitness amenity to the local area

On behalf of Game4Padel, we successfully received planning permission for the installation of two padel courts at Bloom Heathrow Business Park in West London. This formed a wider suite of upgrades to provide exceptional Grade A, sustainability and wellness focused office accommodation at the business park to ultimately increase occupancy across the estate. As the fastest growing sport in Europe, the padel courts provide a valuable leisure and fitness amenity for office workers at the park, as well as local residents.

After an initial refusal, we were appointed to successfully deliver a planning strategy to address LB Hounslow's concerns with a revised submission and planning permission subsequently granted in spring 2023.

The courts are now built out, opening officially in September 2023, and are a valuable amenity at the business park.

Eton College Indoor Sports Facilities

Transforming modern sports facilities at historic Eton College

Our Heritage team provided advice to help inform and guide evolving designs for new and improved sports facilities across two sites within Eton College's historic campus. We undertook research and analysis to understand the heritage significance of the sites and heritage assets. This guided the design process and informed pre-application discussions with Historic England and Windsor and Maidenhead Council.

Positive pre-application engagement was gained with regard to the high quality and sensitivity of the architectural design to its context. We promoted the final scheme at application with a full Heritage Statement to justify and highlight its benefits. The planning application was approved at committee with officer support; now promising a new multi-sports centre and separate aquatics facilities, refurbishment of the historic Rackets Courts building, refurbishment of the Fives Courts and clubroom, and new café. The Sports and Aquatics Centre is now complete, with the next phase in further development.
